Personal Protective Equipment (PPE)				
Pesticide labels are read to determine the required PPE needed.				
The label-required PPE is always worn when applying a pesticide.				
A long-sleeved shirt, long pants, socks, and shoes are worn when applying pesticides.				
Properly sized, chemically-resistant gloves specified on the pesticide label are worn.				
An extra pair of chemical-resistant gloves is with the applicator in case of product failure.				
A cartridge respirator is used if the label requires it.				
A pair of goggles or a face shield is used if the label requires it.				
Chemical-resistant gloves are worn when reading the product label on an open container.				
Each applicator changes work clothing used during a pesticide application as soon as possible.

Storage and Handling				
The pesticide storage area is NOT a part of a residence, office building, or barn holding animals or their feed.				
The pesticide storage area remains locked when not in use.				
Warning signs are posted on the door(s) to the pesticide storage areas.				
No medications, clothing, fertilizer, or combustibles are stored with pesticides.				
Pesticide storage areas are actively ventilated with fresh air from outside.				
Areas where pesticides are stored are always dry and free of debris.				
The pesticide storage area is well lighted.				
The temperature in the pesticide storage areas are maintained between 40-90°F.				
The flooring in the pesticide storage area is made of an impermeable surface.				
All pesticides are stored off the floor.				
Metal shelves with raised edges are used for pesticide storage.				
All pesticides are stored in the original, labeled container.				
All pesticide containers are inspected prior to use to make sure they are not leaking.				
The product label is read before mixing and applying a pesticide.

All pesticide containers are dated when purchased; oldest products are used first.			
Liquid formulations are stored near the floor; dry formulations are stored on shelves above.			
Clean water, hand soap, and paper towels are available adjacent to where pesticides are stored.			
Label-specified PPE are used each time a pesticide is handled or mixed.			
Current Safety Data Sheets (SDS) are kept for each product stored.			
Emergency responders know exactly where pesticides are stored on the property.			
A spill kit is readily available in the pesticide storage area.			
A well-designed mixing and loading pad will contain any pesticide spill.			
There is adequate space available to properly store rinsed containers prior to disposal.
